Deadline based applications

- Translation and interpretation fees,
- Life in the UK and English Language test fees,
- Medical reports and DNA testing.

Such costs are not included in the fees quoted above and are not necessary in every case. You will be notified in advance if you have to pay any disbursements in addition to O'McRaysum Immigration Services fees.
